Notes from recent REIS Board meetings

BLASTING ORDINANCE

Lee County is proceeding with a 6-month, \$185,000 study to learn how blasting at development sites affects nearby properties. The study is being conducted by geologist Frank Lucca, owner of TerraDinamica, a Connecticut firm that has blasting experience in the Caribbean. One obstacle confronting Lucca is the lack of blasting activity to analyze, since it is now prohibited by county ordinance.

SITE DRAINAGE

Lee County's Community Development staff has been meeting with the development community to address storm water management problems. The primary problem involves infill development or building in established neighborhoods. Staff recommendations may be reviewed by Lee Planning Authority (LPA) in January.

DEVELOPMENT CODE CHANGES

Lee County's Land Development Code Committee is discussing staff suggestions to:

- 1) require identification of flow ways within the zoning process;
- 2) define dewatering liability and conditions; and
- 3) consider increasing school impact fees again.

LEE PLAN EVALUATION AND APPRAISAL REPORT

State Dept. of Community Affairs (DCA) has returned the Report to the Lee Planning Dept. with comments and objections, which are now being reviewed by staff.

TRANSPORTATION FUNDING

State funding is shifting focus toward regional needs versus local MPOs (Metropolitan Planning Organizations) to better connect seaports, airports and railroads.

Funding improvements to all transportation systems will diminish funding for highways. Southwest Florida interests are lobbying the state to allocate 25% of funding toward new or **emerging corridors, such as the Ave Maria area.**

The meeting should start at 7 pm.
