CHALLENGES AND STRATEGIES FOR PROPERTY DEVELOPMENT TODAY

LEE REDUCES ROAD IMPACT FEES

Lee County Commissioners have approved a 27% average reduction in road impact fees, effective as of June 15. Reductions in specific categories range from 14 percent for nursing homes to 46 percent for general warehouses. The fee for building a single-family residence drops 25 percent to \$6,701. The fee for building general office space is cut 27 percent to \$5,355 per 1,000 square feet. The complete schedule of fees may be reviewed at <http://www3.leegov.com/dcd>.

CHARLOTTE SUSPENDS IMPACT FEES

Charlotte County commissioners suspended impact fees on new residential and commercial construction for one year, in an effort to promote growth and stimulate construction. The suspended fees are used to pay for libraries, parks, law enforcement, fire department and public buildings. The impact fees used to pay for road construction and maintenance were not suspended. The Charlotte County Economic Development Office says the fee suspensions will cut taxes on construction by half.

AIRPORT LAND USE COMPATIBILITY

Florida Dept. of Transportation (FDOT) and Urban Land Institute (ULI) Southwest Florida will present a program regarding the new Airport Land Use Compatibility Guidebook on July 27 in Fort Myers. Details and registration will be posted at [ULI website](#).

FLORIDA REDISTRICTING MEETINGS

Florida's Legislature has begun the process to reapportion Florida's Senate, House and congressional districts. The purpose is to logically divide the state's 18.8 million residents into 120 House districts, 40 Senate districts and 27 congressional districts. Population growth has earned Florida two new congressional seats and one of those districts may be created in Southwest Florida. The deadline to draw the new maps is March 9, 2012. Public officials are holding regional town hall meetings to gather public input. In Southwest Florida there will be two meetings, both on August 31: 8 - 11 am in the Naples Daily News Community Room in Naples; and 6 - 9 pm in the Veterans Park Recreation Center in Lehigh Acres. CHANGING COUNTY GOVERNMENT

A new local Political Action Committee (PAC), *Families for Freedom & Fairness*, is focused on changing the Lee County Charter to decentralize the current power structure in Lee County government, thus providing better representation to local businesses and the constituency of Lee County, according to PAC organizers.

The PAC leadership asserts that "Lee County is currently structured in a way that the "executive branch" is headed by a County Manager who is appointed by the Board of County Commissioners (BOCC). As the Board retains the authority to hire and fire the Manager, they retain "de facto" executive authority over County affairs. Since the appointed Manager is only accountable to the current Board, taxpayers' concerns tend to become secondary in consideration. The proposed changes would elect the County Manager making him/her accountable to the voters -- NOT the Board."

Furthermore, the PAC would like additional changes, i. e.: "Currently, the BOCC is made up of five Commissioners elected at-large. They are elected to four year terms and are unlimited in the number of consecutive terms allowed. This current structure breeds a culture of incumbency protection making it difficult to bring new blood into the Commission as well as failing to provide proper representation to the constituency. The proposed changes include a transition to a hybrid district model with seven total members, of which there are five single member districts while an additional two members will continue to be elected at-large and will serve as Chair and Vice Chair of the Commission. Additionally, Commissioners will face term limits providing for a total of twelve (12) years of service."

The PAC believes the changes: "Create a climate for lower taxes and regulation through better representation; Provides a more responsive government for local communities through a decentralized power structure; Allows for additional oversight and scrutiny of official actions through the inherent conflict of separated powers; and Provides opportunities for fresh representation in the County Commission." PAC leaders intend to begin a petition drive for signatures on this issue to place proposed changes on the 2012 ballot.
