IMPACT FEES MAY DROP IN LEE

Lee County's recent Road Impact Fee Update report recommends fees be reduced 27% on average based on lower road construction costs and reduced travel demand. The report and draft ordinance, including a schedule of fees for different property types may be reviewed at <http://www3.leegov.com/dcd>. The proposed ordinance will be considered in public hearings with the [Local Planning Agency \(LPA\)](#) at 8:30 am on May 23 and with the [Board of County Commissioners](#) at 5 pm on June 14. Both hearings are in Lee County Commission Chambers. Public comment is welcome. If adopted, the ordinance would become effective when filed with the Secretary of State.

Many other counties and municipalities on the Gulf Coast have reduced impact fees in the past few years to encourage construction and stimulate economic growth.

GROWTH MANAGEMENT REFORM

Governor Scott has signed legislation that reinstates the Growth Management Act passed by the 2010 Legislature and later invalidated by the court. The legislation eases concurrency requirements for developers to provide roads and schools, exempts some larger developments from state review, and allows for extension of development approvals and permits.

The legislation, coupled with the Governor's proposal to eliminate the Dept. of Community Affairs, reduces the state's role in comprehensive planning and gives local governments more authority in managing development.

FORT MYERS ZONING DATA ONLINE

The City of Fort Myers Community Development Department has launched a new web mapping application system that allows citizens and property investors to research parcel zoning, with links to other departments and City Codes. The web map has tools for map navigation, identifying features, measuring distances, finding addresses, viewing the latest aerial photography, and a neighborhood lookup menu. More features to come. UNDERSTANDING VACANCY RATES

The US Census estimates that 30% of Lee County dwelling units are vacant. However, that includes units that are occupied for seasonal, vacation, or occasional use, which is a substantial amount in this area. It also includes units sold or rented but not yet occupied.

LEGISLATIVE UPDATE

1. **Septic Tank Inspection** - Bills to repeal the mandatory septic tank inspection regulation failed but implementation of the law is on hold. The approved budget prohibits spending on the inspection program unless approved by the Legislative Budget Commission and ratified by the 2012 Legislature.
2. **Property Rights** - Property rights bills passed which strengthen property rights protections afforded by the Bert Harris Act, reduce unnecessary litigation, and shifts burden of proof to those challenging permits.
3. **Property Assessments** - Approved constitutional amendments to be on the 2012 ballot which would reduce the yearly assessment cap on nonhomesteaded property to 5% and allow the Legislature to prohibit assessment increases when property values decline.
4. **Florida's One-Stop Business Connect Act** - Failed to pass a bill to streamline issuance of licenses, certifications, and registrations by state agencies by jointly conducting review of state's requirements.
5. **Residential Building Permits** - Approved bill to prohibit local governments from requiring certain types of inspections as a condition to issuing a permit.
6. **Water Management Requirements** - Approved bill establishing agricultural-related exemptions to water management requirements; provides Dept. of Agriculture & Consumer Services exclusive authority to determine whether activities qualify for exemption; and provides exemption for converted agricultural lands.
7. **Corporate Tax Relief** - Approved bill increasing the exemption to corporate income tax from \$5,000 to \$25,000, saving businesses about \$1,100 each.
8. **Insurance Costs** - Legislation passed that limits coverage on sinkhole insurance and allows insurers to pay cash value for repairs rather than paying replacement value up front. Intended to limit factors that increase premiums and to encourage more insurers to operate in Florida.
9. **Title Insurance Protection** - Bill passed that ensures title coverage continues when underwriter fails.
