## RECESSION - RESISTANT MARKETS

In an August 16 story *Forbes* magazine and Zillow.com rated Fort Myers as second among "America's most recession-resistant cities for real estate," with Sarasota rated #7 and Punta Gorda rated #18. The study analyzed stability and appreciation in median home prices. Fort Myers had a 2.9% appreciation rate in the first quarter and 3.7% appreciation in the second quarter.
