News from recent REIS board meetings

Horizon Council:

Horizon Council advocated that Lee County establish a \$25 million economic development incentive fund. Approved by Lee Commissioners Sept. 25th.

REIS reception to honor the new Lee County Board of Commissioners will be December 10, at Edison National Bank, hosted by Edison National Bank and Henderson, Franklin, Starnes & Holt, P.A., Land Use Division.

Legislative Issues:

Lee County Eagle Ordinance: Final public hearing on proposed changes to the Eagle Protection Ordinance is continued to Oct. 28, in Lee Commission Chambers.

Lee County Impact Fees: On Sept. 23rd Lee County Commissioners approved a 4.5% reduction in school impact fees assessed on new residential units. They rejected a study recommendation to raise road impact fees and those fees will remain the same for most projects. Road impact fees on retail and hotel projects will be reduced. The building industry had recommended road impact fees be waived to stimulate the economy. Both decisions by the board were unanimous.

MINING MORATORIUM ENDS, NEW RULES AND FEES ADOPTED

The moratorium on new mining in Lee County's vast DR/GR area expired September 11th.

On September 9th Lee Commissioners adopted revisions to the Land Development Code (LDC) to impose additional restrictions on mining. The new regulations are online at www.lee-county.com/dcd.

On September 23rd, the commissioners approved an impact fee on mining.

Proposed amendments to Lee's Comprehensive Plan will further restrict the areas where mining will be allowed. Plan amendments are scheduled for review by Lee Commissioners in October, the initial step in the process.
