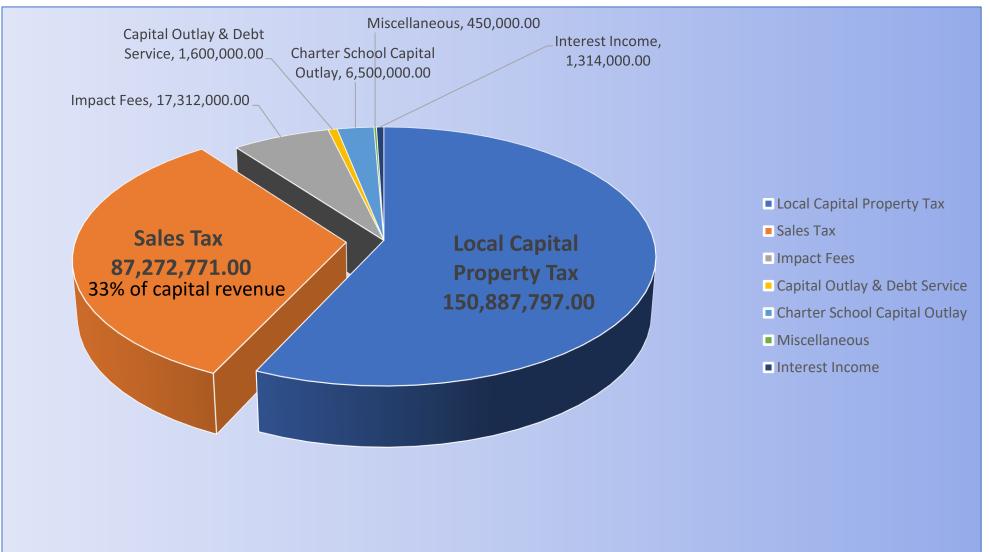

FY22 Capital Revenue - \$265.3M

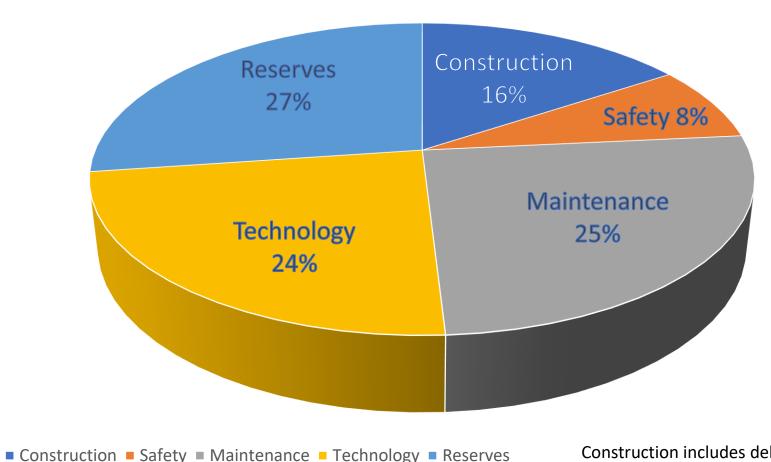




FY22 Sales Tax Budget - \$159,868,811



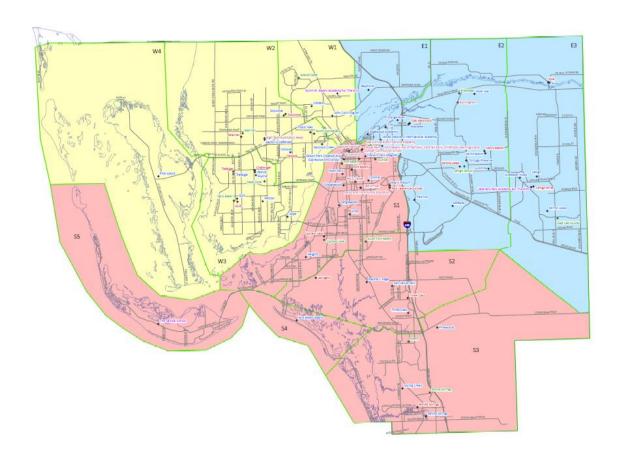
by Sales Tax Category - September 2021

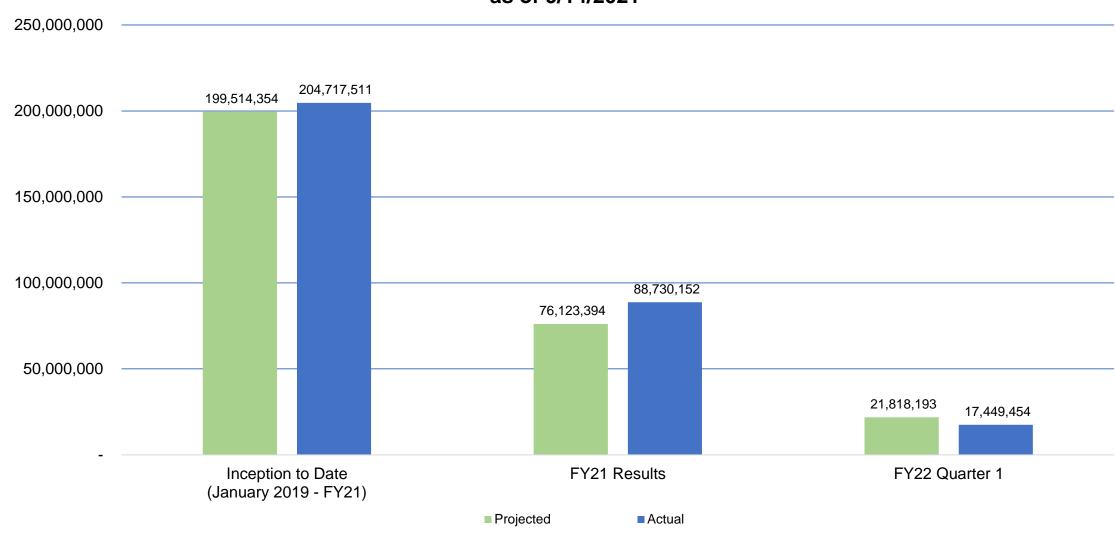

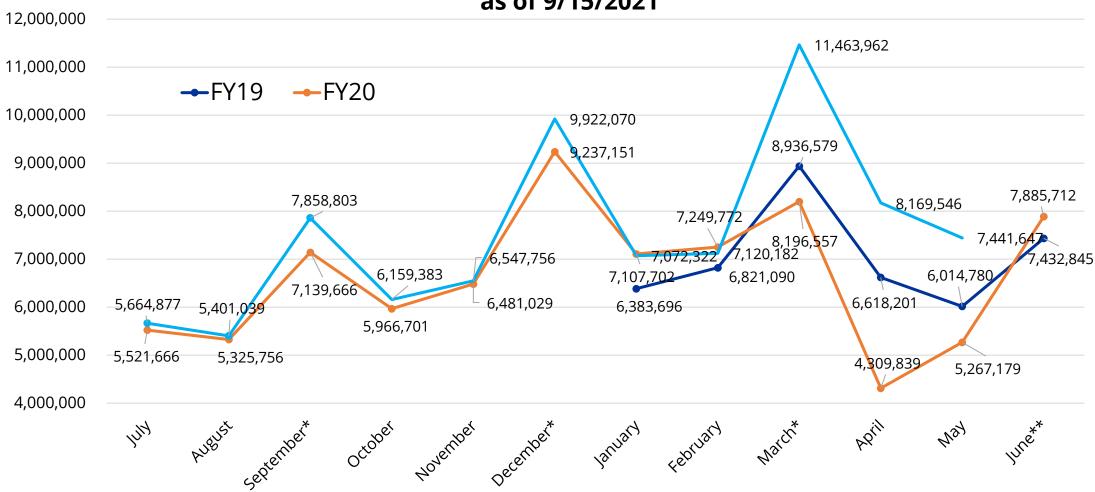




School District of Lee County Sales Tax Revenue as of 9/14/2021

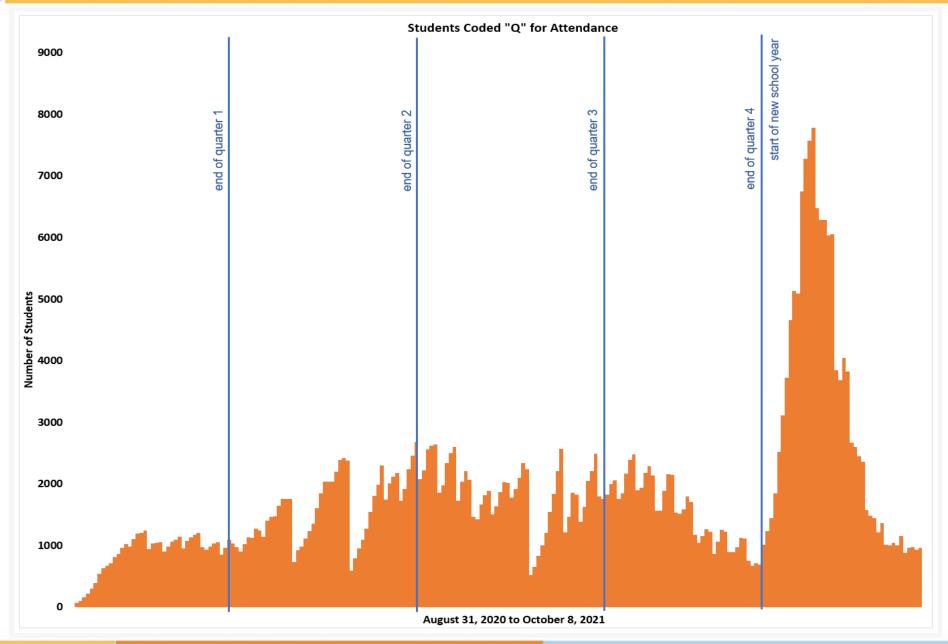

The state implemented a Q code for students who are quarantined or isolated.

On September 22, 2021 DOH issued rule: 64DER21-15

 Parents can opt to send quarantined, asymptomatic students to school.

Health & Safety Protocols General Requirements

An **isolation room** will be maintained at each school for individuals with COVID-like symptoms.

Visitors will not be allowed on campus during school hours.

Students are encouraged to bring their own **water bottles** as water fountains are being limited.



Social Distancing

will occur to the greatest extent possible.

Masks are required as a mitigation measure, but families have the ability to opt-out

Desks facing forward, with flexibility of grouping of students for learning; **assigned seating** and accurate **seating charts** will be kept.

Hand Washing & Respiratory Etiquette will be taught and reinforced.

Hand sanitizer will be available in key places within the school. Students are also encouraged to bring their own.

Health & Safety Protocols Cleaning Measures and IAQ

School Busses will be cleaned and disinfected after each school run in both the morning and the afternoon.

Windows on school busses will be opened when possible to help increase air circulation.

Recess equipment and playgrounds will be disinfected at the end of the day; students will use hand sanitizer or wash their hands before and after being on the playground.



High frequency cleaning of common surfaces will occur throughout the student day using disinfectant products registered with the EPA.

Positive Case Triggered Cleaning Protocols will be deployed when an individual has tested positive and has been in a District vehicle, or building within 24 hours.

Areas where **food is prepared, stored, and served** will be regularly cleaned with food-safe agents.

Quarterly air filtration replacements at high standard

Health & Safety Protocols General Requirements

Volunteers will be allowed on campus during school hours for educational purposes.

Field trips will be District sponsored only with school staff chaperoning.

One way hallways and stairwells



Grab and Go breakfast and lunch

Meals eaten in classrooms; staggered seating in cafeterias to avoid student sitting face to face

Cleaning supplies will be provided

so secondary students can wipe down desks and equipment (i.e. weights)

No locker room use during halftime

Holding on large gatherings like carnivals, festivals and dances (unless they are outside)

Testing & Vaccination

- These opportunities are completely optional.
- In every case, a parent/guardian must be present for a student to receive a test, and/or the vaccine.
- The District will communicate these opportunities to families and employees.
